**b. FSTD Approval Privileges.** The provision of the FSTD to the AOC holder/applicant for:

• The training and checking in accordance operations manual part D
• The revalidation of type rating, type rating instructor rating and synthetic flight instructor rating in accordance with JCAR FCL 1 revalidation requirements.
• ZFTT type rating and type rating instructor courses providing that the foreign FSTD belongs to a TRTO that is approved to provide these training courses

**c. FSTD Approval Conditions.**

• The training and checking will be conducted in accordance with the AOC holder/applicant operations manual part D
• The training and checking will be conducted by AOC holder/applicant type rating instructors (TRIs), synthetic flight instructors (SFIs), type rating examiners (TREs) and synthetic flight examiners (SFEs)
• The AOC holder/applicant training and checking reports detailed in the operations manual part D will be used for the training and checking records
• CARC proficiency check reports and applications will be used for ratings revalidation
• The FSTD will be part of the AOC holder/applicant annual quality system inspection program
• The FSTD shall continue to meet the approval conditions during the period of the approval - 24 calendar months

If the AOC holder/applicant cannot provide his own type rating instructors / synthetic flight instructors and type rating examiners / synthetic flight examiners for the conducts of training and checking, he needs simultaneously to apply for approval to outsource of training and checking to the same TRTO which approval to use FSTD is held
