Subpart –A General

73.1 Applicability.

The airspace that is described in Subpart B and Subpart C of this part is designated as special use airspace. These parts prescribe the requirements for the use of that airspace.

73.3 Special use airspace.

- (a) Special use airspace consists of airspace of defined dimensions identified by an area on the surface of the earth or over territorial waters wherein activities must be confined because of their nature, or wherein limitations are imposed upon aircraft operations that are not a part of those activities, or both.
- (b) The vertical limits of special use airspace are measured by designated altitude floors and ceilings expressed as flight levels or as feet above mean sea level. Unless otherwise specified, the word "to" (an altitude or flight level) means "to and including" (that altitude or flight level).
- (c) The horizontal limits of special use airspace are measured by boundaries described by geographic coordinates or other appropriate references that clearly define their perimeter.
- (d) The period of time during which a designation of special use airspace is in effect is stated in the designation.

73.5 Bearings; radials; distances.

- (a) All bearings and radials in this part are Magnetic track from point of origin.
- (b) Unless otherwise specified, all distances in this part are stated as nautical miles.

Subpart –B Restricted Areas

73.09 General.

Each area is established by coordination between using agency and the controlling agency.

These areas are published in the Aeronautical Information Publication (AIP) and described in the tabulation which indicates their lateral and vertical limits, the type of restriction or hazard involved at which they apply and other pertinent information.

73.11 Applicability.

This subpart designates restricted areas and prescribes limitations on the operation of aircraft within them.

73.13 Restrictions.

No person may operate an aircraft within a restricted area between the designated altitudes and during the time of designation, unless he has the advance permission of

- (a) The using agency described in 73.15; or
- (b) The controlling agency described in 73.17.

73.15 Using agency.

- (a) For the purposes of this subpart, the following are using agencies:
 - (1) The agency, organization, or military command whose activity within a restricted area necessitated the area being so designated.
- (b) Upon the request of the CARC, the using agency shall conclude a letter of agreement establishing procedures for joint use of a restricted area by the using agency and the controlling agency, under which the using agency would notify the controlling agency whenever the controlling agency may grant permission for transit through the restricted area in accordance with the terms of the letter of agreement.

- (c) The using agency shall:
 - (1) Schedule activities within the restricted area;
 - (2) Authorize transit through, or flight within, the restricted area as feasible; and
 - (3) Contain within the restricted area all activities conducted therein in accordance with the purpose for which it was designated.

73.17 Controlling agency.

For the purposes of this part, the controlling agency is the CARC facility that may authorize transit through or flight within a restricted area in accordance with a joint-use letter concluded under 73.15.

73.19 Reports by using agency.

- (a) Each using agency shall prepare a report on the use of each restricted area assigned thereto during any part of the preceding 12-month period ended September 30, and transmit it by the following December 31 of each year to the Chief Commisstioner/CEO.
- (b) In the report under this section the using agency shall:
 - (1) State the name and number of the restricted area as published in this part, and the period covered by the report.
 - (2) State the activities (including average daily number of operations if appropriate) conducted in the area, and any other pertinent information concerning current and future electronic monitoring devices.
 - (3) State the number of hours daily, the days of the week, and the number of weeks during the year that the area was used.
 - (4) For restricted areas having a joint-use designation, also state the number of hours daily, the days of the week, and the number of weeks during the year that the restricted area was released to the controlling agency for public use.
 - (5) State the altitudes or flight levels (whichever is appropriate) used in aircraft operations and the maximum and average ordinate of surface

firing (expressed in feet above mean sea level) used on a daily, weekly, and yearly basis.

- (6) Include a chart of the area (of optional scale and design) depicting, if used, aircraft operating areas, flight patterns, ordnance delivery areas, surface firing points, and target, fan, and impact areas. After once submitting an appropriate chart, subsequent annual charts are not required unless there is a change in the area, activity or altitude (or flight levels) used, which might alter the depiction of the activities originally reported. If no change is to be submitted, a statement indicating "no change" shall be included in the report.
- (7) Include any other information not otherwise required under this part which is considered pertinent to activities carried out in the restricted area.
- (c) If it is determined that the information submitted under paragraph (b) of this section is not sufficient to evaluate the nature and extent of the use of a restricted area, the CARC may request the using agency to submit supplementary reports. Within 60 days after receiving a request for additional information, the using agency shall submit such information to the Chief Commissioner/CEO.

Subpart- C Prohibited Areas

73.81 Applicability.

This subpart designates prohibited areas and prescribes limitations on the operation of aircraft therein.

73.83 Restrictions.

No person may operate an aircraft within a prohibited area unless authorization has been granted by the using agency.

73.85 Using agency.

For the purpose of this subpart, the using agency is the agency, organization or military command that established the requirements for the prohibited area.

Subpart-D Danger Aeras

73.91 Applicability.

This subpart designates danger areas and prescribes limitations on the operation of aircraft therein.

73.93 Restrictions.

No person may operate an aircraft within a danger area unless authorization has been granted by the using agency.

73.95 Using agency.

For the purpose of this subpart, the using agency is the agency, organization or military command that established the requirements for the danger area.

Note:

Flying outside controlled airspace wihin Amman FIR is completely prohibited unless authorized by the appropriate authorities.
